4. NP work programme.

- 4.1. Topic for consideration and development is the Braunton Parish Spatial Vision and Spatial Strategy
- 4.2. SP explained that the Spatial Vision is a narrative description of the desired outcome achieved by planning policies and the Spatial Strategy defines what has to be done to achieve the Vision.
- 4.3. The Braunton Parish Spatial Vision will describe the community and character of the place in 2031.
- 4.4. The Spatial Strategy for Braunton Parish will address how the Vision is achieved across the identified themes grouped by Developed and Natural Environment.
- 4.5. Discussion in respect of the Spatial Vision for Braunton Parish ensued.
 - 4.5.1. Using a large scale map of the Parish key areas for 2013 were identified:
 - 4.5.1.1. Parish SSSI Caen Roost, Chapel Hill, Castle Hill, Taw/Torridge Estuary, Braunton Swan Pool (? HLM)
 - 4.5.1.2. ANOB extension and Biosphere (not just the dunes)
 - 4.5.1.3. ANOB Centre established
 - 4.5.1.4. Historic assets of parish protected
 - 4.5.1.5. Designation of Great Field and other green spaces
 - 4.5.1.6. Creation of nature reserve
 - 4.5.1.7. Flood zones areas where no development will be tolerated
 - 4.5.1.8. Identify / protect those areas at risk of flood in 2031
 - 4.5.1.9. Natural management of water courses throughout the parish
 - 4.5.1.10. Extended AQM zone monitored
 - 4.5.1.11. No buildings above the xx metre line protect the green crown
 - 4.5.1.12. Protect cherished views and skyline
 - 4.5.1.13. Use of "old names" for the local landscape
 - 4.5.1.14. Braunton village hub for ecology, history, surfing, heritage.
 - 4.5.1.15. Braunton locale known for food, music, arts, water sports and outdoor pursuits

- 6.1. RM gave update as to findings in respect of potential funding sources.
- 6.2. Advised that Ashford NP is making bid via Locality and Big Lottery Fund
- 6.3. Ashford has also received some funding from Cllr Chugg for fixed camera in respect of cameras.
- 6.4. Locality funding is now open £9k available with further £8k if meet specific criteria.

- 6.5. Further areas to be investigated Fullerbrook though only in respect of capital assets and the Vivian Moon fund.
- 6.6. RM requires all theme leads to have identified what "spends" they require to support the emerging policies no later than end of June so that funding bids can be prepared.
