Insurance Claim

At the last meeting the Council considered a request from the MOBS to claim on its Zurich insurance policy for storm damage to the MOBS roof. The Council agreed to offer the MOBS a grant for the repairs as there were concerns that not all of the damage was caused by storm Darragh. Members had witnessed youth climbing on the roof. The estimated cost to repair the damage is £800. The Council's excess would be £250 and it is unlikely that the insurance company would approve the claim if the damage could not be proven as storm damage.

The Council noted that part of the grant was retrospective which is not permitted in accordance with the Council's Grant Policy. It agreed that it would be willing to consider providing a grant towards the implementation of measures to prevent

further damage to the roof.

Members considered the MOBS grant request for £2,390 to cover the repairs, provide anti vandal paint and CCTV. It was suggested that the Council arrange to meet with the MOBS Trustees to discuss the issues and the terms of the lease to ensure that the building is properly maintained going forward.
