The proposed small treatment works in the garden of Plot 3 is unacceptable, as it will result in treated effluent being discharged into the nearby watercourse.

He further commented on the traffic movements on Wrafton Road. He requested if it would be possible to install double yellow lines to prevent parking and obstructing this busy road. The grassed verge outside Travis Perkins is constantly churned up because cars have to mount the verge to get passed parked vehicles. The County Cllr agreed to take this matter to highway officers for their consideration.

Report from Devon County Councillor

The County Cllr congratulated the new members of the Parish Council on their election.

Exeter Road – Following the spate of parking problems along the Exeter Road affecting access to Colley Park Road in particular. The County Cllr has asked Highways if they can look again at some solutions. If Highways were to put double yellow lines there it would mean that residents would no longer be able to park outside their houses and would create parking issues elsewhere. The cycle lane cannot be used because of the parked cars and it definitely needs some road markings across the visibility splays.

Refuge Islands – The County Cllr was pleased to update members that the three damaged refuge islands along the Exeter Road have finally been replaced.

Funding Announcement – The County are waiting for the government to announce the successful Active Travel funding bids which should be any day. This will hopefully provide funding for the next stage of the Tarka Trail to Foxhunters (The Woodpecker). Planning permission has gone in this week for the section.

Love Braunton have objected as it is over intensification of development on the site and it does not reflect the character of development in the neighbouring properties. The development will also have a negative impact on the calmative traffic volumes. The Applicant has not addressed the following conditions:

 Condition 8 lacks the requisite detail needed to manage flood risk on what is a very wet site

- Condition 9 requires a treatment plant which appears to have been meet but no consideration is given to impact upon Knowl Water quality which is already the recipient of waste runoff by adjacent developments
- Condition 10 addresses the visibility splay and the developer appears to have submitted a vehicle speed survey conducted for 1 hour in the middle of the day and which bears no resemblance to residents experience
- Condition 12 Landscape scheme requires details of lighting – there is none
- Condition 16 documents indicate that there will be a loss of 9 healthy mature trees, some of which will negatively impact the lane scape

RESOLVED: That Standing Orders be reinstated.

RESOLVED: That the Council recommends refusal on the grounds, as follows:

- Over intensification of development on the site.
- The proposed development is not in keeping with the surrounding area and not sympathetic to the character of developments in neighbouring properties, as detailed in the Braunton Design Guide.
- Insufficient drainage to cope with the size of the development.
- Inadequate surface water drainage. Watery Lane which lies adjacent to the site is known to flood, this development would exacerbate the current situation regarding surface water flooding.
- Concerns regarding the loss of 8 mature trees and part of the hedge bank. These should be replaced as stipulated in NE4(iv)— Protecting Devon Banks, Hedgerows and Trees in the emerging Neighbourhood Plan.
- The proposed development would result in an increase in the volume of traffic entering and leaving the highway which is considered to be insufficient for the additional traffic flow, and consequently would result in the risk of additional danger to all users of the road in accordance with Policy DM27.

If the Local Planning Authority is minded to approve this application the dwellings should be for primary residency in accordance with Policy H1 in the emerging Braunton Neighbourhood Plan.
